In the following cases very complex situations regarding tax problems have been made simple.

- 1. V**** Steels, Mumbai :- 4 Complex cases of ITAT Reply filed alongwith Supreme Court Citations, Cases decided in Assessee's Favor on Merits.
- 2. E. Pro**** Navi Mumbai: Huge Demand was created to the tune of 1.40 Crs., due to mismatch of Taxes paid and other issues. Cases were very Old 08-09 to 12-13. Matter was continuously monitored with A.O. As a result demand was reduced to Nil & Refund of around 60 Lacs received by Assessee
- 3. **** Kutty: Assessee was a regular tax payer failed to show some properties, came to Tax Maestro for IDS. Assessee calculated values wrongly at a very high rate. He was properly Advised to declare the value as per IDS rule. Thus legally, his Tax liability was reduced to the great extent. His Accounts were corrected. Returns of all Family members were filed and made updated.
